NEW 2000-2001 DVA CAR STICKERS

Dear Residents/Members:

The new 2000-2001 DVA stickers will be available starting 16 October 2000 at the DVA office. The old '99-2000 stickers will be valid until 15 November 2000.

The issuance of the new stickers shall be subject to the following guidelines:

- **CATEGORY I** - Regular stickers issued to bonafide residents of the village and their immediate family.

1-6 stickers	-	P150.00/sticker
7-12 stickers	-	P650.00/sticker
13 and over	-	P1,200.00/sticker

- **CATEGORY II** - Limited Stickers issued to relatives, friends, employees or executives sponsored by residents and which includes embassy personnel.

The DVA Limited Stickers shall be used to enter and exit Dasmarinas Village only and may not be used for other villages.

A resident may sponsor a maximum of twelve (12) limited stickers at the following rates:

1-6 stickers	-	P650.00/sticker
7-12 stickers	-	P1,200/sticker

Additional limited stickers may be requested subject to the approval of the President or the Vice President.

- All new stickers shall be issued only to residents who are up to date in the payment of their association dues and other assessments.

- DVA reserves the right to ask the resident for a certificate to clarify relationship.
- To serve you better, a schedule shall be devised by assigning a specific day for issuance of the new stickers based on the last digit of your home address number as follows:

<u>Last Digit</u>	<u>Days of Issuance of Stickers</u>	<u>Time</u>
1 & 2	Every Monday	8 AM-12 NN / 1 PM-5 PM
3 & 4	Every Tuesday	" "
5 & 6	Every Wednesday	" "
7 & 8	Every Thursday	" "
9 & 0	Every Friday	" "

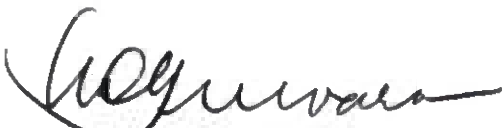
THE ABOVE SCHEDULE IS GOOD ONLY FOR THE PERIOD OCTOBER 16 TO NOVEMBER 30, 2000, AFTERWHICH ISSUANCE OF STICKERS SHALL BE ON A REGULAR SCHEDULE.

Please submit the following requirements in securing the new DVA sticker:

1. Photocopies of the certificate of registration and latest official receipt from the LTO to show that the car is owned by the resident/homeowner and/or applicant sponsored by the resident. *Deed of Sale* will not be honored.
2. Application form duly filled up and signed by the resident for his own vehicles, company owned vehicles designated to him and vehicles of others he is sponsoring.
3. For company or embassy owned cars, a certification from the company/embassy designating the car to the resident/homeowner.
4. The vehicle must be brought to the DVA office and a DVA staff will affix the sticker on the car windshield.
