NEW 2004-2005 DVA CAR STICKERS

Dear Residents/Members:

The new 2004-2005 DVA stickers will be available starting October 11, 2004 at the DVA office. The 2003-2004 stickers will be valid until October 31, 2004.

The issuance of the new stickers shall be subject to the following guidelines:

 CATEGORY I – Regular Stickers for private cars only (no stickers will be issued for trucks, buses, ambulances and other commercial vehicles owned by residents) issued to bonafide residents of the village and their immediate family.

> 1 to 6 stickers 7 to 10 stickers beyond 10 stickers

P 250.00/sticker P 750.00/sticker

P 750.00/sticker

P1,800.00/sticker + discretionary issuance

 CATEGORY II – Limited Stickers issued to relatives, friends, employees or executives guaranteed by sponsor-resident. Sponsor-resident must execute a guarantee the form of which is attached hereto as Annex A.

The DVA Limited Stickers shall be used to enter and exit Dasmarinas Village only and may not be used for other villages.

A resident may sponsor a maximum of ten (10) Limited Stickers at P2,500.00 per sticker.

- Sticker for motorcycles of residents is priced at P250.00 each.
- All new stickers shall be issued to residents who are up to date in the payment of their association dues and other assessments.

 Specific days will be assigned for issuance of the new stickers based on the <u>last digit</u> of your <u>home address number</u> as follows:

THE ABOVE SCHEDULE IS GOOD ONLY FOR THE PERIOD OCTOBER 11 TO NOVEMBER 19, 2004. AFTERWHICH ISSUANCE OF STICKERS SHALL BE ONGOING DURING OFFICE HOURS.

Please submit the following requirements in securing the new DVA sticker:

- 1. Photocopies of the certificate of registration and latest official receipt from the LTO to show that the car is owned by the resident/homeowner and/or applicant sponsored by the resident. **Deed of Sale** will not be honored.
- 2. Application form duly filled up and signed by the resident for his own vehicles, company owned designated to him and vehicles of others he is sponsoring.
- 3. Letter from resident sponsoring or authorizing the sale and issuance of stickers to non-residents.
- 4. For company or embassy owned cars, a certification from the company/embassy designating the car to the resident/homeowner.
- 5. The vehicle must be brought to the DVA office and DVA staff will affix the sticker on the car windshield.
