D.V.A. CIRCULAR NO. 2005 – 30

2005 - 2007 DVA CAR STICKERS

Dear Residents/Members:

The **2005-2007** DVA stickers will be available starting October 3, 2005 at the DVA office ONLY. The 2004-2005 stickers will be valid until October 28, 2005. Starting year 2007, stickers will be issued on the month of April instead of October, hence, the stickers that will be issued this year will be valid until March 2007. Sticker prices have been adjusted pro-rata.

The following guidelines shall be used in the issuance of the new stickers:

- **CATEGORY I Regular Stickers** - for private cars only issued to bona fide residents of the Village and their immediate family:

1 to 6 stickers	-	P 360.00/sticker
7 to 10 stickers	-	P1,070.00/sticker
11 to 20 stickers	-	P2,550.00/sticker + discretionary issuance
- **CATEGORY II Limited Stickers** - issued to light commercial vehicles owned by residents and to relatives, friends or employees guaranteed by sponsor-resident who must execute a guarantee, the form of which is available at the DVA office.

The DVA Limited Stickers shall be used to enter and exit Dasmarinas Village only and may not be used for entry into other Makati Villages.

A resident may sponsor a maximum of ten (10) Limited Stickers at P3,540.00 per sticker.

- **Motorcycles.** - Stickers for motorcycles of residents are P360.00 each. Regular stickers will be issued to motorcycles of residents and will not be counted against the first six (6) stickers. Motorcycles used by members of the staff of a resident shall be issued the sticker that is exclusive for Dasmarinas Village only.
- Stickers shall only be issued to residents who have paid their association dues and other assessments.

- Specific days will be assigned for issuance of the new stickers on the last digit of your address as follows:

<u>Last Digit of Address</u>	<u>Day of Issuance of Stickers</u>	<u>Time</u>
1 & 2	Every Monday	8 AM - 12 NN/1PM - 5 PM
3 & 4	Every Tuesday	" "
5 & 6	Every Wednesday	" "
7 & 8	Every Thursday	" "
9 & 0	Every Friday	" "

THE ABOVE SCHEDULE IS ONLY FOR THE PERIOD OCTOBER 3 TO OCTOBER 31, 2005
AFTERWHICH ISSUANCE OF STICKERS SHALL BE DURING REGULAR OFFICE HOURS.

Please submit the following when securing the new DVA sticker:

1. Photocopies of the certificate of registration and latest official receipt from the LTO to show that the car is owned by the resident/homeowner and/or applicant sponsored by the resident. **Deed of Sale** will not suffice.
2. Application form duly filled up and signed by the resident for his own vehicles, designated company-owned vehicles and vehicles of others being sponsored.
3. Letter from resident sponsoring or authorizing the sale and issuance of stickers to non-residents, when applicable.
4. For company or embassy owned cars, a certification from the company/embassy designating the car to the resident/homeowner.

N.B.: Each vehicle must be brought to the DVA office where DVA staff will affix the sticker on the car windshield.

DVA CIRCULAR NO. 2005-27

NEW DVA ID SYSTEM

The Dasmariñas Village Association, Inc. will be introducing a **new village Identification System starting on 26 August 2005**. The new ID may be issued to residents, household staff and regular or contracted service providers.

The new System incorporates the following:

1. A **computerized database** which allows the storing of relevant basic information readily available and which can be used for immediate verifications and background check on employees.
2. An **SMS and Internet verification procedure**, which will allow residents to directly verify if an ID presented is authentic or valid and the information given by an employee is correct. This is an initial means of checking the background of a would-be employee.
3. A **bar-coded ID card** which will facilitate better Pedestrian Access Control at all the Village gates. Initially, all 3 Village pedestrian gates at Palm Avenue, Pasay Road and Amorsolo Street will be equipped with a computer sub-system, which will electronically regulate pedestrian access (e.g., security personnel would be alerted if pedestrians with IDs have clearance to enter or not and a record of entry will be maintained). This set-up will allow Village security personnel to focus on inspections and verifications of persons without DVA-issued IDs.
4. A **"Flagging Feature"** whereby individuals who have been involved in nefarious activities, have committed gross/blatant misdemeanors, or have committed a crime will not be granted ready access into the Village and victimize other residents.

Two types of identifications will be issued – a **Regular DVA ID, which is valid for 1 year at a cost of P 100.00**; and a **Temporary DVA ID, which is valid for a maximum of 30 days at a cost of P 20.00**. All types of IDs may be **readily cancelled or revoke and suspended**.

Except residents/tenants and DVA & Barangay Staff, ID applicants are required to present pertinent valid documents depending on the nature of work or service even during renewal hereof.

The following procedures are to be followed:

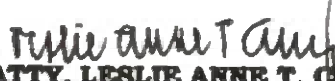
- Step 1: Secure ID Request Forms & Individual Application Forms [Available at the Security Office anytime]
- Step 2: Payment of fee [DVA Cashier/only during office hours]
- Step 3: Application [Security Office ID Processor/only during office hours]
- Step 4: Processing [Security Office ID Processor/only during office hours]
- Step 5: Releasing [Security Office/anytime]

Do note that:

1. All information regarding the employers and/or residents in the DVA ID System shall remain **STRICTLY CONFIDENTIAL**, with limited access thereto by authorized and designated DVA personnel.
2. Previously issued DVA identification cards shall remain valid and will be honored until their expiration, except when earlier cancelled or revoked.
3. To verify the authenticity or validity of the DVA ID and the status of the employee, you may text the **14 digit ID Number** to the following:
