2012-2013 DVA CAR STICKERS

Dear Residents/Members:

The **2012-2013** DVA stickers will be available starting MAY 21, 2012 at the DVA office ONLY. The 2011-2012 stickers will be valid until June 20, 2012. Starting this year, DVA will implement the RFID Vehicle Access System as a solution to the use of fake stickers. With the removal of Magallanes Village in the Makati Intervillage Agreement (MIVA) on vehicle access, vehicles with DVA sticker cannot freely access said Village effective June 20, 2012 and will be subjected to its normal access procedures.

The following rules will be observed in the issuance of the new stickers:

- **CATEGORY I Regular Stickers** - for private cars which will be issued to *bona fide* residents of the Village and their immediate family:

1 to 6 stickers	-	P 400.00 each
7 to 12 stickers	-	P 950.00 each
13 to 20 stickers	-	P2,200.00 each
21 up	-	P2,500.00 each + written approval from the DVA President or Security Chairman
- **CATEGORY II Limited Stickers** - issued to light vehicles owned by residents' relatives, friends or employees guaranteed by sponsor-resident who must execute a guarantee, the form of which is available at the DVA office.

The DVA Limited Stickers shall be used to enter and exit Dasmarinas Village only and cannot be used for entry into other Makati Villages.

A resident may sponsor a maximum of ten (10) Limited Stickers at P3,000.00 per sticker.

- **Motorcycles** - Stickers for motorcycles of residents are P400.00 each. Regular stickers will be issued to motorcycles of residents and will not be deducted from the first six (6) stickers. Motorcycles owned and/or assigned to staff of residents shall not be issued any sticker for security reasons.
- **Exclusions** - Stickers will only be issued to residents who have paid their association dues and other assessments, and who have no pending violations of deed restrictions or Village Rules whether or not covered by a court or HLURB case. Lessors of properties being used as consular or visa processing offices will be issued DVA-only (limited) stickers at the price of regular stickers.

No stickers will be issued to vehicles being used for commercial/business purposes and to those with company name, logo and product/services markings.

- **Large vehicles** - Vehicles with a seating capacity of more than 15 persons will be issued limited stickers at a price of ₱3,000.00 each and will be assessed a parking fee of ₱5,000.00/month if said vehicle is parked along Village streets. Vehicles of this type with MIVA stickers not issued by DVA but parked along Village streets will also be assessed a parking fee of ₱5,000.00/month.
- **Issuance** - Specific days will be assigned for issuance of the new stickers in accordance with the last digit of the resident's address as follows:

1 & 2	Every Monday	8 AM to 12 NN/1PM to 5 PM
3 & 4	Every Tuesday	" "
5 & 6	Every Wednesday	" "
7 & 8	Every Thursday	" "
9 & 0	Every Friday	" "

THE ABOVE SCHEDULE IS ONLY FOR THE PERIOD FROM MAY 16 TO JUNE 20, 2012 AFTERWHICH ISSUANCE OF STICKERS WILL BE DURING REGULAR OFFICE HOURS.

Please bring the following documents when securing the new DVA sticker:

1. Photocopies of the certificate of registration and latest official receipt from the LTO to show that the vehicle is owned by the resident/homeowner and/or applicant sponsored by the resident. **Deed of Sale** will not suffice. Vehicles owned by a resident/homeowner with 2011-2012 stickers are not required to submit a copy of the certificate of registration and latest official receipt.
2. Photocopy of latest Lease Contract if applicant is a lessee of the property that he/she is occupying.
3. Application form duly filled up and signed by the resident for his own vehicles, designated company-owned vehicles and vehicles of others being sponsored.
4. Letter from resident sponsoring or authorizing the sale and issuance of stickers to vehicles of non-residents, when applicable.
5. For company or embassy owned cars, a certification from the company/embassy designating the vehicle to the resident/homeowner.

N.B.: Each vehicle must be brought to the DVA office where DVA staff will affix the sticker on the vehicle's windshield.
