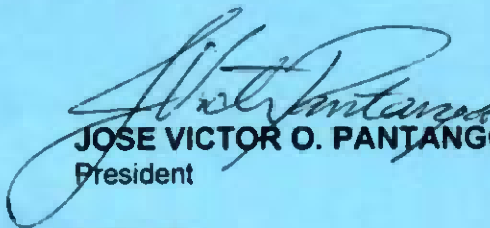
RE: DVA GUIDELINES FOR JOGGERS & BIKERS

Please be informed that your Board during its regular meeting, approved the Security, Safety & Traffic Committee's recommendation to regulate and provide guidelines for joggers and bikers inside Dasmariñas Village.

Non-resident joggers/bikers must apply for a DVA Joggers/Bikers I.D. and must be sponsored by a DVA resident or homeowner before being allowed to enter the Village.

We have attached a copy of the Application Form with corresponding guidelines for your ready reference. Additional form may be acquired from the DVA Security Office.

Please be guided accordingly.

DVA GUIDELINES FOR JOGGERS AND BIKERS

- Non-resident/outsider shall not be allowed entry for jogging and biking into the village unless he/she was sponsored by a resident/homeowner.
- Joggers/Bikers ID is valid only for 30 days subject to renewal.
- ID Registration fee is Php 100.00
- He/She shall secure Dasmarinas Village ID with the sponsorship of the Dasmarinas Village resident/homeowner with an endorsement letter.
- DVA will not be responsible for any loss/damage of property, injury, accident, of all joggers/bikers incurred while inside the village.
- The issued ID shall be in his/her possession at all times while inside Dasmarinas Village and readily available to present upon the village guard's request.
- Jogger/Biker asserting that he/she was sponsored by a resident shall be subject for verification prior to entry. No matter what time. When approved by the resident, jogger/biker should be advised to secure DVA Jogger's/Biker's ID.
- DVA Jogger's/Biker's ID is non-transferable and cannot be used to sponsor other person/s.
- Village gate guards reserve the right to deny entry of anybody (non-resident) who wishes to enter the village for the purpose of jogging/biking activity.
- Joggers/Bikers must strictly observe the proper usage of jogging/biking designated lanes/streets at all times.
- Group biking for competitive training is prohibited.
- Littering is not allowed inside the village. Violators will be fined a fee of P500.00.
- Bikers must observe the speed limit of 20 kph. Over speeding will be apprehended and fined.
- Bikers should not at anytime obstruct the flow of vehicular traffic.
- Bikers must always observe the right of way of all pedestrians.
- Joggers/Bikers must avoid excessive noise at all times.
- Joggers/Bikers must wear the proper protective gears, appropriate uniform while inside the village.
- DVA has the right to revoke/cancel the issued ID of a jogger/biker who repeatedly commits violations against DVA rules and regulations
- Lost/missing issued DVA ID must be reported immediately to DVA Security Office for cancellation and replacement.
- Each household is only allowed to sponsor three (3) joggers or bikers.
- Use of Mahogany gate shall be exclusively for the use of Dasmarinas and Forbes Park residents.
