2014-2015 DVA CAR STICKERS

Dear Residents/Members:

Please be informed that the **2014-2015** DVA stickers will be ready for distribution starting June **16**, 2014 at the DVA office <u>ONLY</u>. The 2013 stickers will be valid until July **15**, 2014.

Magallanes Village is no longer a member of the Makati Inter-village Agreement (MIVA) on vehicle access so vehicles with DVA sticker cannot freely access said Village and will be subjected to its normal access procedures.

The 2014 DVA car stickers will still have RFID tags similar to all MIVA stickers with inter-village access. Here are the rules to be observed in the issuance of said stickers:

 CATEGORY I REGULAR/INTER-VILLAGE STICKERS. – issued to private cars of bona fide residents of DASMA and their immediate family:

1 to 6 stickers - ₽ 400.00 each
7 to 12 stickers - ₽ 950.00 each
13 to 20 stickers - ₽2.500.00 each

- CATEGORY II LIMITED/NON-INTERVILLAGE STICKERS. issued to private cars of:
 - DASMA residents starting on the 21st car at P5,000.00 each.
 - Residents' relatives, friends or employees guaranteed by sponsoring resident who must execute a guarantee, the form of which is available at the DVA office, with a price of P5,000.00 each.

The DVA Limited stickers can access Dasmariñas Village only.

- Motorcycles issued to motorcycle owned by a DASMA resident at P400.00 each. Regular stickers will be
 Issued to motorcycle of residents and will not be deducted from the first six (6) stickers. Motorcycles owned
 and/or assigned to staff of residents shall not be issued any sticker for security reasons.
- Exclusions Stickers will only be issued to residents who have paid all their association dues and
 assessments. Those with pending violations of DVA Deed Restrictions or Rules & Regulations whether or not
 covered by a court or HLURB case and Lessors/Lessees of properties being used as consular or visa
 processing offices will be issued Limited stickers at the price of regular stickers.

No stickers will be issued to commercial vehicles and to those with business name, logo and product/services markings.

- Large vehicles Vehicles with a seating capacity of more than 15 persons will be issued Limited stickers at a price of P5,000.00 each and will be assessed a parking fee of P5,000.00/month if parked along DASMA streets.
- Days of Issuance Specific days will be assigned for issuance of the new stickers based on the <u>last digit</u> of the resident's address as follows:

THE ABOVE SCHEDULE IS ONLY FOR THE PERIOD FROM JUNE 16 TO JULY 15, 2014, AFTERWHICH, ISSUANCE OF STICKERS WILL BE MADE DURING REGULAR OFFICE HOURS.

 Campanilla Street will be one-way from Mahogany going to Gioriosa from June 16 to July 15, 2014 to minimize traffic congestion.

Please bring the following documents when securing the new DVA sticker:

- Photocopies of the certificate of registration and latest official receipt from the LTO to show that the vehicle is owned by the resident/homeowner and/or applicant sponsored by the resident. Deed of Sale will not suffice. Vehicles owned by a resident/homeowner with 2013 stickers are not required to submit a copy of the Certificate of Registration and latest Official Receipt.
- 2. Photocopy of latest Lease Contract if applicant is a lessee of the property that he/she is occupying.
- 3. Application form duly filled up and signed by the resident for his personally-owned vehicles, designated company-owned vehicles and vehicles of others being sponsored.
- Letter from resident sponsoring or authorizing the sale and issuance of stickers to vehicles of non-residents, when applicable.
- For company or embassy owned cars, a certification from the company/embassy designating the vehicle to the resident/homeowner.

N.B.: Each vehicle must be brought to the DVA office where DVA staff will affix the sticker on the vehicle's windshield.
