DVA STREET PARKING RULES & REGULATIONS

Dear Residents:

This is further to Circular No. 2014-16 dated July 2, 2014 and Circular No. 2014-22 dated September 27, 2014, informing you of our Village street parking concerns which in the judgment of your DVA Board have to be immediately addressed.

With the best interest of the greater majority of our residents in mind and incorporating some of the suggestions/proposals we received from residents who responded to our previous surveys on street parking, your DVA Board approved a resolution prescribing **"DVA PARKING RULES AND REGULATIONS AIMED AT REDUCING THE VOLUME OF VEHICLES PARKED ALONG VILLAGE STREETS BY LIMITING THE NUMBER OF VEHICLES A RESIDENT IS ALLOWED TO PARK, DESIGNATING AREAS WHERE VEHICLES CAN PARK OR CANNOT PARK AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF."**

DVA VEHICLE PARKING GUIDELINES, **RULES & REGULATIONS**

- I. **General Rule:** No vehicle shall be parked on village streets and sidewalks anytime from 9:00 PM to 6:00 AM. *Exception:* Residents may be allowed to park on the streets but only for their excess vehicles that cannot be accommodated inside their lot or garage and subject to the prescribed rules and regulations as below listed.

- II. **Specific Rules And Regulations**
 - A. Only vehicles with valid parking stickers which can be secured from the DVA office for a fee shall be allowed to park on the street and at DVA designated areas from 9:00 PM to 6:00 AM. *Note: We are currently negotiating with property owners to allow us to use their vacant lots as temporary parking areas.*
 - B. Only two (2) vehicles with valid DVA parking stickers may park on the street and on the side of the resident's house from 9:00 PM to 6:00 AM.
 - C. Residents may park their vehicles in front or on the side of another resident's house or vacant lot but a written consent of the owner shall first be secured, a copy of which shall be furnished the DVA office.
 - D. Motorbikes and bicycles of residents and of their staff and guests, golf carts, motorboats, and all terrain and commercial vehicles shall be parked inside the lot or garage of the resident at all times.
 - E. The one-side parking along Banyan, Mahogany and Lumbang streets shall only be from 6:00 AM to 9:00 PM starting January 5, 2015.

- III. **Rate Of The Dva Parking Sticker**
 - Each DVA parking sticker is One Thousand Pesos (P1,000.00) per month. The DVA parking sticker shall be issued by DVA starting on December 1, 2014.

- IV. **Penalty Provisions**
 - Residents found to be in violation shall be fined as follows:
 - A. P500.00 for the First Infraction
 - B. P700.00 for the Second Infraction
 - C. P1,000.00 for the Third and each succeeding Infraction
 - Violators who fail to pay the fine(s) imposed on them shall not be issued vehicle stickers which DVA issues annually.
 - All fines shall be paid only to the DVA cashier.

- V. **Effectivity Date**
 - The foregoing parking rules and regulations shall take effect on January 5, 2015.

- VI. **The following existing parking rules and regulations shall continue to be enforced:**
 - A. No vehicle, including motorbikes and bicycles, shall be parked at all times along Palm Avenue and in front of Fire Hydrants, Street Curbs and both sides of Campanilla and Mahogany Parks.
 - B. No vehicle shall be parked along the jogging lane (ecology side) of Amorsolo Road from Lumbang Street to Tamarind Road from 6:00 a.m. to 9:00 p.m. except in emergency cases (fire, flood and the like).
 - C. "Overnight Parking" at Amorsolo Road from the gate to Palm Avenue shall not be allowed.
