UPDATE ON STREET PARKING RULES & REGULATIONS

Dear Residents:

Pending resolution on the final version of the "OVERNIGHT PARKING RULE" which may include some of the proposals and suggestions that several residents presented in their formal letter to DVA and were reiterated during a meeting held at the Pavilion last December 9, 2014, please be informed that the DVA Board shall implement the other Street Parking rules that are not related to the "OVERNIGHT RULE" which the Board approved earlier. These street parking rules which were mentioned in DVA Circular Nos. 2014-16 dated July 2, 2014 and 2014-22 dated September 27, 2014, are necessary to preserve the peace, order and harmony in our community and for the general safety of our Village that may be jeopardized due to improper parking of vehicles.

The final version of the "OVERNIGHT PARKING RULE" will be finalized before the issuance of the 2015 car stickers which we intend to release on May 2015. For your benefit and information, we reprinted in the attached sheet these Street Parking Rules & Regulations, which shall be implemented ten (10) days from the date of this circular.

DVA PARKING RULES & REGULATIONS

I. SPECIFIC PARKING RULE

- A. Residents and their guests may park their vehicles on the street fronting their property with a maximum of two (2) vehicles per lot.
- B. Residents and their guests may park their vehicles in front or on the side of another resident's house/lot provided a written consent of the owner shall first be secured, a copy of which shall be furnished the DVA office. This rule shall not apply on the streets where the One-Side Parking Rule is implemented, namely: Banyan, Lumbang and Mahogany.
- C. Motorbikes, bicycles, golf carts, boats, jet ski, trailers, all kinds of carts, sidecars, all terrain and commercial vehicles shall be parked inside the lot or garage at all times.
- D. No vehicle shall be parked at all times in front of fire hydrants, street curbs/corners and in front of Mahogany Park, Kamias side.
- E. No vehicle shall be parked along the jogging lane (Ecology side) of Amorsolo Road, from Lumbang to Tamarind Roads except during times of emergencies.

II. PENALTY PROVISIONS

- Those found to be in violation of the above rules & regulations shall be fined, as follows:
 - a) \$2500.00 for the first infraction
 - b) #700.00 for the second infraction
 - c) P1,000.00 for the third and each succeeding infraction
- Violators who fail to pay the fine(s) imposed on them shall not be issued vehicle stickers.
- All fines shall be paid only to the DVA cashier.
