D.V.A. Circular No. 2015 – 15

June 22, 2015

Dear Fellow Residents:

We are pleased to inform you that the 2015-2016 Dasmariñas Village Inter-Village Car Stickers will be ready for distribution starting July 1, 2015 at the DVA Office. The 2014 car stickers will be valid and honored until July 31, 2015 only.

In the collective effort of the homeowners associations of Bel-Air, Dasmariñas, Forbes Park and Urdaneta Villages to address the increasing volume of vehicular traffic in the villages that poses a threat to the security and safety of residents and contributes to the deterioration of the peaceful environment in its communities, the Makati Inter-Village Security Network (MIVA SecNet) approved certain changes in the 2015 unified vehicle stickers issuance policy. These changes which were later affirmed by their respective Board of Governors aim to reduce the volume of vehicles of non-residents using the internal road network of the villages which contributes to the rapid deterioration of the village roads. As a result, the sticker allocation for this year 2015 will be 15 stickers per property and may be further reduced to 12 stickers per property in 2016.

The new sticker issuance guidelines to be implemented are as follows:

- **Strict maximum of FIFTEEN (15) inter-village stickers per property.**
- **In excess of the allocated 15 inter-village stickers per property, limited stickers valid only for ingress/egress at the issuing village will be issued (e.g. Dasmariñas Village access only).**
- **Vehicles of non-residents (sponsored by a resident) shall be issued only with a limited or village-specific sticker (i.e. Dasmariñas Village access only).**
- **Residents are encouraged to declare truthfully in the application form if the vehicle is resident-owned or owned by a non-resident being sponsored for a Dasmariñas Village sticker.**

The MIVA SecNet also agreed on the following uniform pricing of vehicle stickers:

- **For the 15 DVA-MIVA Stickers (with inter-village access)**
 - First 5 - ₱ 500.00 per sticker
 - Second 5 - ₱1,000.00 per sticker
 - Next 5 - ₱3,000.00 per sticker
- **In excess of 15 MIVA stickers and stickers for sponsored non-residents**
 - Limited or no inter-village access - ₱6,000.00 per sticker

Specific days will be assigned for issuance of the new stickers based on the last digit of the resident's address as follows:

THE ABOVE SCHEDULE IS ONLY FOR THE PERIOD FROM JULY 1 TO JULY 31, 2015, AFTERWHICH, ISSUANCE OF STICKERS WILL BE MADE DURING REGULAR OFFICE HOURS.

Campanilla Street will be one-way from Mahogany going to Gloriosa from JULY 1 to JULY 31, 2015 to minimize traffic congestion.

Please fill up the attached Vehicle Sticker Request Form and submit to the DVA Office together with your payment and the listed requirements. As per DVA Collection Policy, no sticker will be issued to residents/members with unpaid dues and other assessments including unsettled fines or penalties for any violation of DVA Rules and Regulations. You may also refer to the attached copy of the complete guidelines on sticker issuance.

The 2015-2016 DVA stickers will continue to have an embedded RFID (radio frequency identification) tag uniform to all MIVA stickers with inter-village access.

2014 DVA Vehicle Stickers Issuance Guidelines

I. MIVA SEC.NET POLICY

- Strictly maximum of fifteen (15) Inter-Village Stickers per property.
- In excess of the allocated 15 Inter-Village Stickers, limited stickers valid only for ingress/egress at the issuing village (i.e. Dasmariñas Village sticker only; no Inter-village access) shall be issued.
- Vehicles of non-residents (sponsored by a resident) shall be issued only with a Limited sticker (i.e. Dasmariñas Village sticker only, no inter-village access).
- Residents are encouraged to honestly declare in the vehicle sticker application form if the vehicle is resident-owned or owned by a non-resident being sponsored for issuance of a sticker.
- The privilege of access to the other villages using an Inter-Village Sticker is for passing through only and not for parking inside a village unless visiting a particular resident thereat.
- Owners/Drivers of vehicles bearing an Inter-Village Sticker issued by any of the MIVA villages must obey all traffic rules and regulations not only of the issuing village but of the other member villages as well. Fines Imposed for any traffic violation must be settled promptly. Serious traffic violations may result to the revocation of the inter-village access and cancellation of the sticker issued to the vehicle subject of the violation.
- Removal of sticker and affixing it to another vehicle is strictly prohibited. Penalty for this violation is ₱5,000.00.
- All vehicles issued with Inter-Village Sticker shall be strictly for private use of the owner. However, if such conveyances are used as public utility/for hire vehicles or for any other commercial activity, the issued stickers shall be automatically invalidated. In addition, a fine of ₱5,000.00 shall be imposed.

IV. OTHER IMPORTANT MATTERS

1. Vehicle stickers will be issued only to members/residents who are updated in the payment of their membership dues and other assessments. Members on delinquent status are not entitled to issuance of vehicle stickers.
2. Members/Residents who were previously cited for traffic violations and who have not paid yet the fines/penalties must settle first the unpaid fines before issuance of a new sticker to the particular vehicle subject of traffic citation is processed. Members/residents with pending case with DVA will only be issued limited sticker.
3. The vehicle must be brought to the DVA Office and authorized personnel will affix the sticker onto the designated location on the vehicle's windshield.
4. In case of transfer of ownership to a non-resident member or non-resident, the DVA Office must be notified of the sale. The DVA sticker on the vehicle must be removed and surrendered for cancellation before the vehicle is turned over to the new owner.
5. No sticker will be issued to commercial vehicles and to those with business name, logo, product/services markings or with telephone numbers, email address.
6. Motorcycle owned by a Dasmariñas resident will be issued a regular sticker at ₱500.00 each and will not be deducted from the 15 inter-village stickers. No stickers will be issued to staff of residents for security reasons.
