D.V.A. CIRCULAR No. 2015 - 18

DVA STREET PARKING

Dear Residents:

You will recall that last year, your DVA Board of Governors passed a resolution aimed at enhancing the safety of the Village by reducing the volume of vehicles parked along the Village streets and sidewalks especially during nighttime through the introduction of an OVERNIGHT PARKING STICKER rule which requires a resident to secure a parking sticker from the DVA office for a certain fee before said resident can be allowed to park his vehicle on the street. The said rule was explained and discussed in our Circular No. 2015-02 dated January 31, 2015, Circular No. 2014-24 dated November 21, 2014, Circular No. 2014-22 dated September 27, 2014 and Circular No. 2014-16 dated July 2, 2014.

Please be advised that your DVA Board of Governors has decided NOT to pursue the "OVERNIGHT PARKING STICKER FOR A FEE" Policy but shall continue to implement the following parking rules and regulations:

DVA PARKING RULES AND REGULATIONS

I. SPECIFIC PARKING RULES (24/7)

- A. Residents and their guests may park their vehicles on the street fronting their property with a maximum of two (2) vehicles per lot.
- B. Residents and their guests may park their vehicles in front or on the side of another resident's house/lot provided a written consent of the owner shall first be secured, a copy of which shall be furnished the DVA office. This rule shall not apply on the streets where the One-Side Parking Rule is implemented, namely: Banyan, Lumbang and Mahogany.
- C. Motorbikes, bicycles, golf carts, boats, jet ski, trailers, all kinds of carts, sidecars, all terrain and commercial vehicles shall be parked inside the lot or garage.
- D. No vehicle shall be parked in front of fire hydrants, street curbs/corners and in front of Mahogany Park, Kamias side.
- E. No vehicle shall be parked along the jogging lane (Ecology side) of Amorsolo Road, from Lumbang to Tamarind Roads except during emergency.

II. PENALTY PROVISIONS

- Those found to be in violation of the above rules and regulations shall be fined as follows:
 - a) P500.00 for the first infraction
 - b) P700.00 for the second infraction
 - c) \$1,000.00 for the third and each succeeding infraction.
- Violators who fail to pay the fine(s) imposed on them shall not be issued vehicle stickers.
- All fines shall be paid only to the DVA cashier.
