- Days of Issuance Specific days will be assigned for issuance of the new stickers based on the <u>last</u> digit of the resident's address as follows:

20 DVA Vehicle Stickers Issuance delines

I. MIVA SEC.NET POLICY

- Strictly maximum of fifteen (15) Inter-Village Stickers per property/lot.
- In excess of the allocated 15 Inter-Village Stickers, limited stickers valid only for ingress/egress at the issuing village
 (i.e. Dasmariñas Village sticker only; no inter-village access) shall be issued.
- Vehicles of non-residents (sponsored by a resident) shall be issued only with a Limited sticker (i.e. Dasmariñas Village sticker only, no inter-village access).
- Residents are encouraged to honestly declare in the vehicle sticker application form if the vehicle is resident-owned or owned by a resident being sponsored for issuance of a sticker.
- The privilege of access to the other villages using an inter-Village Sticker is for passing through only and not for parking inside a village unless visiting a particular resident thereat.
- Owners/Drivers of vehicles bearing an Inter-Village Sticker issued by any of the MIVA villages must obey all traffic rules and regulations not only of the issuing village but of the other member villages as well. Fines imposed for any traffic violation must be settled promptly. Serious traffic violations may result to the revocation of the inter-village access and cancellation of the sticker issued to the vehicle subject of the violation.
- Removal of sticker and affixing it to another vehicle is strictly prohibited. Penalty for this violation is \$25,000.00.
- All vehicles issued with Inter-Village Sticker shall be strictly for private use of the owner. However, if such
 conveyances are used as public utility/for hire vehicles or for any other commercial activity, the issued stickers shall
 be automatically invalidated. In addition, a fine of P5,000.00 shall be imposed.

RENEWAL (with 2015 DVA vehicle sticker)

- 1. Duly filled up Vehicle Sticker Request form;
- 2. Payment of corresponding fee.

NEW APPLICATION

- Duly filled up Vehicle Sticker Request form;
- Copy of most recent Official Receipt (OR) and Certificate of Registration (CR);
- For brand new vehicles without OR & CR yet, any valid proof of ownership by the property owner/ Resident (Sales Invoice and Delivery Receipt);
- 4. If the vehicle is registered under a company name or by an embassy, a certification issued by its authorized signatory stating that the vehicle is assigned for use of the resident applicant:
- 5. Payment of corresponding fee;
- For lessee or tenant, photocopy of latest contract of lease.

IV. OTHER IMPORTANT GUIDELINES

- Vehicle stickers will be issued only to members/residents who are updated in the payment of their membership dues and other assessments. Members on delinquent status are not entitled to issuance of vehicle stickers.
- Members/Residents who were previously cited for traffic violations and who have not paid yet the fines/penalties must settle first the unpaid fines to qualify for a new sticker. Members/residents with pending case with DVA will only be issued limited sticker.
- 3. The vehicle must be brought to the DVA Office and authorized personnel will affix the sticker onto the designated location on the vehicle's windshield.
- 4. In case of transfer of ownership to a non-resident, the DVA Office must be notified of the sale. The DVA sticker on the vehicle must be removed and surrendered for cancellation before the vehicle is turned over to the new owner.
- No sticker will be issued to commercial vehicles and to those with business name, logo, product/services markings or with telephone numbers, email address.
- 6. Motorcycle owned by a Dasmariñas resident will be issued a regular sticker at P500.00 each and will not be deducted from the 15 inter-village stickers. No stickers will be issued to staff of residents for security reasons.
