Dear CSA Parent:

In an article published in the Philippine Star, statements were attributed to CSA parents who claimed difficulties in entering Dasmarinas Village resulting in inconvenience for them and their children. It was stated that these parents did not want to be identified. This continuing disinformation does not in any way help resolve the issue. We would like to believe that this is a false attribution to you CSA parents and this is part of the continuing disinformation that are being spread by CSA authorities. But if, indeed, these are your statements please consider the fact that even DVA residents and members are required to secure stickers for identification. Why then do you think you should be exempted from this rule?

As we have stated in our previous letter, we believe that the sole driver of this disinformation and legal actions being undertaken by CSA authorities is nothing but a quest to gain more profit. As we pointed out in our previous letter, the dues that they pay is ₱2.75M. Their demand of a 35% share of the sticker fees based on the 2016 figures would amount to ₱3.885M resulting in them recouping all their payments for dues and pocketing a profit of ₱1.135M.

It is crystal clear that this disinformation and legal actions are meant to pressure DVA to hand over to them 35% of the sticker fees which they used to enjoy. As we have also stated in the past, the current Rector is a signatory to an agreement which states: ***"Dasmarinas Village, through DVA, has rules and regulations for the security, peace and tranquillity of its residents. Therefore, CSA shall exert its best effort to make its constituents observe such rules and regulations"***.

They are already making a handsome profit from the P650M in tuition fees that they collect from you. Their payment of dues is an obligation to the community that hosts them and in fact considering that CSA has 5,000 students and generates 50% of the traffic in Dasmarinas Village the dues that they pay is inadequate to cover costs for the security and maintenance of our roads. As we requested you in the past please dialogue with them to try to enlighten the CSA authority that they must abide by the agreement that they signed so that this matter can be resolved to avoid inconvenience for everyone.
